The meeting was called to order at 3:01 p.m.

Mr. Lisk provided the motion to adopt the agenda, seconded by Mr. Wooten, and the motion was unanimously approved.

Dr. Williams provided a motion to approve the October 17, 2024 minutes, seconded by Mr. Wooten, and the motion was unanimously approved.

Ms. Tuck presented an Early Childhood Integrated Data System (ECIDS) policy to be approved.

Dr. Williams made a motion to approve the SC ECIDS Sustainability Policy. The motion was seconded by Mr. Lisk and unanimously approved.

Ms. Tuck provided information on her background and her role as the Harvard Strategic Data Fellow.

Ms. Williams shared a shoutout to the First Steps First Five team.

Mr. Leach shared that DSS presented their budget to the Governor's office that included requests for child welfare, adult protective services, domestic violence, and child care. DSS asked for over \$30 million related to child care: \$26 million for the child care wage bonus, \$1 million for a tri-share child care pilot model, and additional funding for vouchers. He shared that DSS has also asked for funding for in-home visiting programs, with a philanthropy partner that will match that for at least up to 10 years. He asked for support in crafting a narrative between DSS, Children's Trust, and SC First Steps. He also shared that there is a report available on the use of covid federal dollars for childcare.

Ms. Diggs shared that Charleston early head start childcare partnership is a new grantee under Skycap. She also shared that the Migrant Head Start Program moved from Charleston to Columbia because there are more migrant children in the Saluda area than any other part of the State. As a result, Richland County First Steps is an early head start grantee. She also shared that there are now new Head Start performance standards.

Dr. Simmer shared information about DPH's pre and postnatal mobile unit, to serve 14 counties that do not have obstetric care. He stated that DPH is requesting for over \$1 million for the Hear Her campaign. He stated that there has been a significant increase in WIC participants and DPH has received \$12 million from the federal government for WIC and DPH has asked the legislature for permission to use the funds.

Ms. Oliver reported on the activities of the ECAC and ICC and shared analytics on Palmetto PreK and First Five SC. She shared information on the Summit on Early Childhood and thanked ECAC agency partners that are sponsors of the summit.

Mr. Lisk made a motion to adjourn the meeting, seconded by Mr. Wooten, and approved unanimously.

WELCOME

ICC Chair Amber Gillum convened the meeting at SC Department of Disabilities and Special Needs.

BIRTH THROUGH FIVE PLAN

Karen Oliver proposed aligning B5 reporting with state agency reports that are due in September. ECAC/ICC partners would share early childhood data in September for compilation. ICC would receive a draft report for review in late September/early October. ECAC would receive the report at its October meeting. Contents will include 2024-2025 achievements, shared priorities for 2025-2026 (as expressed in 2025-2026 budgets), and updates on B5 Plan measures (the seven measures of progress)

ICC members agreed this timeline worked for them. Many operate on a July-June fiscal year, such that year end data would be available.

ECAC will offer a Birth through Five Plan Progress Brief for February. Contents will include data and reporting related to 2024 priorities. A draft report will be available for ICC review before January 31.

ICC MEETING DATES

Oliver proposed meeting three to four times per year. The ICC will meet in in January and May of this fiscal year, then August or September to discuss the Birth through Five Plan report. ICC members agreed that meeting less frequently would be more efficient but might require longer meetings.

STRENGTHENING SC'S EARLY CHILDHOOD SYSTEM

ICC members agreed to develop an early childhood landscape to better understand the breadth and depth of services available to families with young children. ICC will share data and estimates relating to early childhood programs services and funding. The data generally will be readily available. ICC members agreed that data and funding information from previous years would be sufficient to start. ICC members also noted that it would be important to describe funding and eligibility restrictions for service. ECAC staff will follow up with individual ICC members.

ICC UPDATES AND OPPORTUNITIES

The Coordinating Council on Workforce Development (CCWD) identified child care as an issue that impacts workforce. An ad hoc committee which includes Child Care Resource and Referral, First Steps and DSS is meeting to bring better attention to this issue to the CCWD.

Barnwell and Aiken have a new Head Start provider, Acelero.

ICC will meet the May 12, at 1:30 PM. SC First Steps will host the meeting.

Staff Report on Early Childhood Advisory Council Activities February 2025

Research, Strategy, and Data Governance

The South Carolina Birth Through Five Plan Progress Brief is complete. This brief reports progress on priorities identified in 2024.

The Early Childhood Advisory Council website is being refreshed. Once completed, the updated website will host the ECAC Data Hub, a repository of early childhood data.

Family-Centered Practice

The Family Voice Council is welcoming several new members in 2025. The February meeting will be held with WIC, looking at communications with families and soliciting member feedback on WIC outreach efforts.

A First Five Stakeholder Engagement Report was released late December 2024. Two groups or cohorts integrated their publicly funded programs into the First Five common application by December 31, 2024. These groups represent school districts, Early Head Start and Head Start, and Maternal Infant Early Childhood Home Visiting (MIECH-V) parenting programs.

The First Five SC teams is collecting requirements and agreements to begin a new group in March:Barnwell School DistrictCalhoun School DistrictChester School DistrictSaluda School District

Field Building and Professional Development

The Alliance for Early Success, ZERO TO THREE (ZTT) launched a community of practice (CoP) to grantees to elevate family voice and leadership in policymaking processes. Two representatives from SC First Steps / ECAC met their CoP colleagues in person in January, and will meet virtually through August 2025. Twelve states are participating in this project.

First Five SC and WIC will present at the National WIC Association Conference in April. Rachal Hatton-Moore, First Five SC project manager, Berry Kelly, WIC Director, and a Family Voice Council alum will offer a panel presentation to share how First Five offers easy access to critical programs and services.
